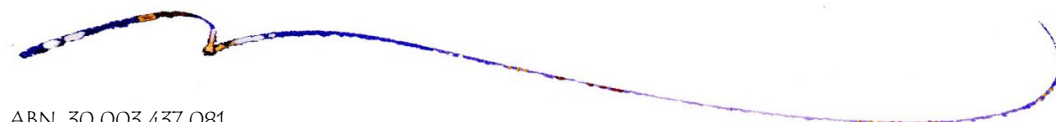

Mumbulla School for Rudolf Steiner Education Scholarship Conditions

1. Eligibility

- Applicants must be permanent residents of Australia and provide evidence of financial hardship (e.g., tax return or Centrelink Income Assessment).
- The child must be turning six years old in their first year of enrolment.

2. Application for Scholarship

One full scholarship will be awarded, covering all tuition fees and levies for the recipient's entire primary education (Kindergarten to Class 6).

- Applications must be submitted using the **Scholarship Application Form**, with all required documentation.
- Parents/Guardians must demonstrate their commitment to Mumbulla School by signing the **Application for Enrolment**.

3. Duration of Scholarships

The scholarship continues through to Class 6, unless it is cancelled (see below)

- Parents/Guardians must sign the Mumbulla School Parent/Guardian and Student Code of Conduct.
- The recipient's eligibility may be reviewed annually by the Scholarship Committee.

4. Cancellation of Scholarships

A scholarship may be cancelled if:

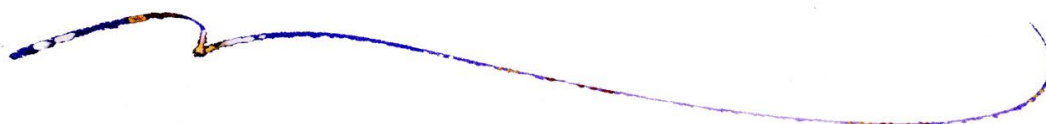
- the recipient's financial status changes, allowing for payment of school fees
- the recipient is suspended or expelled from School
- the student leaves the School

5. Application Time frame

- a. **Opening Date:** 1 July 2025
- b. **Closing Date:** 31 August 2025

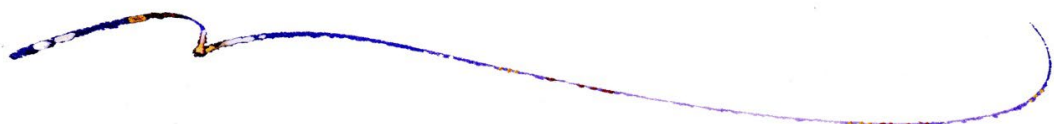
6. Notification of Applicants Outcome

- All applicants will be notified of their application outcome.
- Shortlisted candidates will be invited to a Scholarship Interview with the Scholarship Fund Management Committee.
- The scholarship recipient's identity will **remain confidential**; no public announcement will be made.
